



DANCEATTITUDE WAIVER

I have voluntarily enrolled my child for activities at DanceAttitude.

I accept that the activities will involve strenuous physical activity, including, but not limited to, muscle strength and endurance training, cardiovascular conditioning and training, and other various strenuous fitness activities.

I hereby, on behalf of myself and my spouse, children/minor participants, affirm that my child is in good physical condition and does not suffer from any known disability or condition which would prevent or limit their participation in these activities. I have been advised that an examination by a physician should be obtained by anyone prior to commencing a fitness and/or exercise program or initiating a substantial change in the amount of regular physical activity performed. If I have chosen not to obtain a physician's consent prior to enrolling my child for this activity, I hereby confirm that I am doing so solely at my own risk. I understand it is my responsibility to consult a doctor to inquire whether any activity is appropriate before my child participates in such activity. I understand that the activity is not medically supervised, and exercise activities are led by independent dance instructors.

DanceAttitude follows the industry standards and best practices for the safety and security of all of its members, guests, participants, and staff. DanceAttitude regards and enforces the procedures related to the safety and security of its members, guests, participants, and staff with top priority without any compromise.

I understand that any exercise or dance activities involve a risk of injury. I understand that such risks include but are not limited to slips and falls, trips, collisions, overexertion, loss or theft of property (including from lockers), equipment failure or malfunction, drowning, or other accidents or incidents that may result in harm, loss, disability, death, or other injury or damage to my child. I understand that such injuries may include, but are not limited to scrapes, bruises, sprains, torn or damaged muscles or ligaments, broken bones, burns, respiratory or auditory problems, concussions, strokes, heart attacks or stress, lost wages, lost earning capacity, lost or stolen property, pain and suffering, disfigurement, paralysis, brain damage, or death ("Injury" or "Injuries"). I understand that such Injuries may be caused, in whole or in part, during the activity by myself, my child, other participants, and/or other members or guests.

The undersigned hereby provides consent to and grants DanceAttitude the exclusive right to use and reproduce any and all photographs, slides, moving pictures, audio and visual recordings, or testimonial accounts taken by DanceAttitude that contain my child's name, image, voice, likeness, or account, for any lawful purpose whatsoever and using any means available, including but not limited to any of DanceAttitude's records, corporate public relations or marketing communication materials, videos, or online materials, social media campaigns, either with or without my child's name or photo accompanying such quotation. I waive the right to inspect, approve, or edit any such use or reproduction, and DanceAttitude may make any and all changes, modifications, rearrangements, additions or deletions in its use reproductions without any approval.
